Junior Tennis Instructor Information

The Junior Instruction Program is comprised of 3, 3-week sessions. Participants meet twice weekly on either Monday/Wednesday or Tuesday/Thursday at Thompson Park, Fancyburg Park, or Jones Middle School. Fridays are rain make-up days.

Fee is \$66 per session, six lessons of one hour each, if paid/postmarked on or before the deadline for each session. Cost is \$72 if paid after the session deadline. Evening sessions for juniors are held at Fancyburg Park.

New for 2011

New for juniors this summer are 3, 2-week sessions at Northam Park. Participants meet daily Monday through Thursday. Fridays are rain makeup days.
